

Terms & Conditions

1. RTS MicroNetworks Pvt. Ltd. hereafter called as "Company"
2. The Company provides Service all over India for Road Traffic Service hereafter called as "RTS"
3. RTS includes a free unique QR sticker hereafter called as "RTS-QR"
4. RTS is registered with one vehicle at one time on the name of vehicle owner hereafter called as "Vehicle Owner"
5. RTS is useful to inform vehicle owner on his/her registered mobile no. and vehicle owners alternate emergency mobile no. in case of No Parking Problem and Major Accident Problem of vehicle respectively.
6. The vehicle owner or the Person authorized by vehicle owner on behalf of vehicle owner to process for registration of RTS with the Company/ Authorized Company Executive. In any case Vehicle Owner is responsible related to RTS Registration and the information provided.
7. Validity of RTS is for 3 Years. After three years renewal option is available as per the company policy.
8. RTS once registered shall not be transferred to other vehicle in any case.
9. No Guarantee- Warranty of RTS-QR is provided by the company.
10. Company is not responsible for non working of RTS/ RTS-QR due to technical/legal issues.
11. Company is not responsible for misuse of RTS or RTS-QR by individual/ Organization.
12. Company is not responsible with any type of legal, technical, economical, Social matters if arises in future by using or misusing of RTS or RTS-QR.
13. Company is not responsible for Vehicle theft or damage due to accident or by any other means
14. Any person can scan RTS-QR of RTS registered Vehicle and inform Vehicle Owner on his/her Registered Mobile No. for vehicle's No Parking Problem, the difference between any two scans will be minimum of 10 minutes and only Four attempts are allowed in a Day
Any person can scan RTS-QR of RTS registered Vehicle and inform Vehicle Owner's Alternate Emergency Mobile. the difference between any two scan will be minimum of 60 minutes and only Two attempts are allowed in a Day
When RTS-QR scanned 2 options will be appeared on the mobile Screen
1. No Parking Problem 2. Major Accident Problem.
When select No Parking Problem, message appeared on the Registered Mobile of vehicle owner as.
"I hope you are safe, Your RTS registered vehicle may have No Parking Problem." Thanks! RTS Team.
When select Major Accident Problem, message appeared on the Emergency Mobile of vehicle owner as.
"I hope you are safe, Your RTS registered vehicle may be in Accidental Emergency." Thanks! RTS Team.
15. The Name, Mobile No. of the person scanning RTS-QR for No Parking Problem or in Major Accidental Problem, will not be visible for the company or any other person, but the company shall shear available data i.e., IP Address, location, or any other as required for any type of legal or Police matter.
16. Company has full right to deactivate the RTS if found the vehicle owner has done unlawful or any illegal activities
17. Company has full right to change the policy time to time as required without any prior intimation or permission.
18. GST included in the price of RTS .
19. Subject to Nagpur jurisdiction only.
20. RTS Authorized Executive shall make available online RTS Registration Form along with the QR for payment to vehicle Owner having following mandatory fields shown as.
